*The Association strives to "Build Stronger Counties for Tomorrow" by working with member counties in the fields of research, information exchange, educational promotion and legislative reporting.*

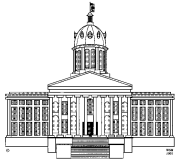

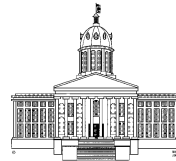


### ***Land Use, Natural Resources and Transportation***

**OPPOSE** — S. C. Department of Transportation efforts to transfer ownership of state-maintained roads to the counties.

**SUPPORT** — an increase in the state gasoline sales/use tax of up to five cents per gallon to provide funds for the maintenance of existing state roads.

- The largest percentage of most county budgets is spent on law enforcement and detention. It is likely that local government will be unable to keep up with the costs of law enforcement, especially since they will not be able to adjust for population increases.



### ***Public Safety, Corrections and Judicial***

**SUPPORT** — the recommendations of the S. C. 9-1-1 Advisory Committee relating to E-9-1-1 and VoIP (voice-over-internet protocol) charges in order to simplify collections and to hold local jurisdictions harmless in the transition to a uniform surcharge.



### ***County Government and Intergovernmental Relations***

**OPPOSE** — H.3615, the spending cap legislation, that limits a local entity’s increase in total expenditures for all operating purposes only up to the increase in the Consumer Price Index (CPI) plus the entity’s percentage increase in population in the previous year.

- County governments are already subject to spending caps by Act 388. Act 388 contained a hard cap on the millage rate and a cap on valuation increases upon which the millage is levied. Property taxes remain the biggest source of revenue for county governments.
- It will be difficult to prepare for known future increases in population. Many of the expenditures associated with new residents must occur prior to people moving into a new subdivision, i.e., roads, storm sewers, water, sewer, etc.

**SUPPORT** — municipal annexation legislation that:

- Makes adhesion contracts null and void.
- Provides a procedure for deannexation in a manner similar to county boundary changes.
- Creates a mechanism to freeze revenue from business licenses upon the annexation of a business.
- Grants legal standing to counties on all annexations within their borders.

- Requires municipalities to notify counties of proposed annexations so that counties can actively participate in the proposed annexation.
- Requires municipalities to analyze the impact of proposed annexations on service delivery to insure that they will be in place after annexation.
- Requires municipalities to submit a development plan outlining how services will be provided in order to avoid gaps in services or overlapping services.
- Provides a mediation process for disputes over whether the annexation is consistent with the comprehensive land use plan.
