

FY 2009 State Mandated Supplements, Salaries, and Per Diems for County Officials

State Salary Supplements for County Officials

Auditors/Treasurers: \$19,972 salary only estimate*; 1% COLA increase

***The above salary estimate reflects salaries budgeted as of July 2008. Mid-year across the board budget cuts for the state of South Carolina were imposed January 2009. As a result, county auditors and treasurers salaries were cut an estimated \$233.85 per pay period for the remainder of FY 2009 and the gross remaining salary after cuts is \$574.28 per pay period.**

Sheriffs: \$1,575; 0% increase

Clerks-of-court: \$1,575; 0% increase

Registers of deeds: \$650.54; 0% increase

Coroners: \$1,575; 0% increase

Probate Judges: \$1,575; 0% increase

Probate Judge Salary: Based on a salary schedule which uses base salaries determined by population categories according to the latest official United States Decennial Census. Salaries are annually adjusted using the COLA provided for state classified employees from the previous fiscal year (a 3% increase).

Master-in-Equity Salary:

State Employee Meal Reimbursement: Actual expense reimbursed, not to exceed \$25/day in-state and \$32 day out-of-state.
