## Tax Anticipation Notes Issued in 2008-2009

**RESULTS:** A total of 40 counties (87%) responded. Of the respondents, 6 stated they had issued TANs in FY 2009. The amount ranged from \$600K to \$3 million, and the interest rate ranged from 2.34% to 4.67%.
