# Benefit/Importance of Project

Union County, like much of rural SC, has struggled to retain the youth of our county. Yearly census estimates show a trend of declining population across rural America in general. Much of this decline in population can be attributed to quality of life challenges and lack of opportunity. These negative trends have long term community impacts which include economic development and workforce challenges as well as increasing levels of poverty. Improving access to higher education and training is a key indicator and driver of quality of life. In addition, SC Department of Education Data indicated that 40% of Union County High School graduates were not pursing post-secondary educational opportunities. Union County partnered with local industry, Spartanburg Community College, the University of SC Union, and the Union County School District to improve higher education and training access for local residents.

# Project Description/Benefit & Importance

This multiyear project focused on improving access to higher education by removing economic barriers and enhancing local educational opportunities. The project consisted of the Union County Community Scholarship Program, creation of the Spartanburg Community College Union Campus, and establishing a nursing school at the University of SC Union, and Operation Workforce Training.

### Union County Community Scholarship Program (2016)

The Union County Community Scholarship Program is a partnership between the Union County School District, Spartanburg Community College, University of SC Union, and Union County. Under the program, Union County Council annually appropriates funds which allow Union County students who earn a diploma or GED to attend the Spartanburg Community College Union Campus or the University of SC Union tuition free. This program was intended to remove economic barriers to local graduates and increase the number of residents obtaining post-secondary training.

### Spartanburg Community College Union Campus (2016)

Union County partnered with the Timken Foundation, the Union County legislative delegation, and Spartanburg Community College to establish the Spartanburg Community College Union Campus. Under the partnership, Union County supplied the facility for the operation with the state of SC and the Timken Foundation providing

funding for a mechatronics program. The program currently provides welding, healthcare, and mechatronics training opportunities for local residents. In addition, the Union County School District partnered with Spartanburg Community College to transfer the adult education program from the school district to the college. This transfer allows adult education students to take dual enrollment classes to further their education.

# Operation Workforce Training(2018)

Union County partnered with local industry, the Union County School District, and Spartanburg Community College to establish the Union County Operation Workforce Training program. Under the annual program, Union County high school seniors and recent graduates who have no plans for pursuing college are allowed to receive free training related to quality control, OSHA practices, and fork-lift certification. At the end of a 65 hour training program, students receive OSHA, forklift operator, and Manufacturing Skills Standards Council quality certifications and interview with local industry for positions. Union County provided the funding to pilot the program and staff coordinate the program each year. Spartanburg Community College has provided grants to fund the program after the pilot program was successful. In addition, Lockhart Power, a local utility company, provides a \$500 cash stipend to students who complete the program.

# <u>University of SC Union Nursing Program(2019)</u>

Union County, the University of SC Union, USC Aiken, and the legislative delegation partnered to establish a nursing program in Union County. The local hospital and healthcare providers have struggled to recruit and retain healthcare professionals in Union County. This project served a dual purpose of providing additional educational opportunities for local residents and improving access to primary healthcare by training local residents who are more likely to live and work in their home community. Under the program Union County provided the facility for the nursing school and provided additional tax millage to support the University and this program.

## **Project Effort/Difficulty**

Executing these types of multiagency/multidiscipline projects are very challenging. Bringing all stakeholders together to establish common vision and direction was key to the success of the project. Union County leveraged public-private and public-public partnerships. Often, public-public partnerships are particularly challenging as agencies who have historically operated in silos attempt to work toward common goals. In addition, governing bodies often struggle understanding the need to work in another area of government and how all of our public agencies are interconnected and interdependent in terms of achieving success. Our entire community coalesced around the vision of improving opportunity for our residents to obtain the skills needed to improve their quality of life.

# **Project Originality/Innovation**

Local county government, particularly in rural South Carolina, typically does not have the time or resources to become intimately involved in this type of education initiative. The state of SC has provided a high degree of separation between education and local government. In rural areas where quality of life issues are key to sustainability and growth, local governments cannot afford to not partner and work with education and private industry to drive quality of life improvements. These rural communities cannot address quality of life barriers to growth without combining resources to address these types of issues.

# Key Project Results/Indicators to Date

- 1. Enrollment at our post-secondary training institutions has increased:
  - University of SC Union-has doubled enrollment to 1153 students since introduction of scholarship and nursing programs
  - Spartanburg Community College Union Campus- enrollment of 70 students for Spring 2020
- 2. Operation Workforce Training has graduated 35 students to date with local industry hiring the majority of graduates

# Scholarship Eligibility and Guidelines

# **Entrance Guidelines for High School Graduates**

- Students must be a current resident of Union County;
- Students must have graduated from Union County High School, Union County Adult Ed, Union Christian Day School, or an approved Union County Home School Program in the previous three academic years or be early graduates in the spring or summer terms;
- Students must enroll within 3 calendar years of high school graduation or completion of GED;
- Students must complete a FAFSA on time and use all federal grants, state awards and other scholarship funds first;
- Awarded scholarships pay tuition and fees, and do not include payment for books and lab fees;
- Students attending USC Union must meet all qualifications for the Life Scholarship to participate;
- Students attending SCC Union County Campus must meet all qualifications for the LTAP or Life Scholarship to participate;
- Students must meet the same criteria for making satisfactory academic progress that recipients of federal financial aid programs must meet;
- Students must enroll in classes offered at the SCC Union County Campus or USC Union to be considered for this scholarship.

# **Scholarship Continuation Guidelines**

- Students attending USC Union must take 30 semester hours and maintain a 3.0 grade point average to quality for the scholarship their second year.
- Students attending SCC Union County Campus must maintain a 2.5 grade point average or better to qualify for the scholarship their second year.
- Students must maintain persistent semester-tosemester enrollment.
- Scholarship program awards will apply towards up to 15 semester hours at SCC Union County Campus or up to 18 hours at USC Union each semester (after approval for any federal, state or other scholarship grants which the student is eligible) and up to five consecutive semesters, o a maximum of 60 credit hours at USC Union and 73 credit hours at SCC Union County Campus.






