# **Registration Information**

SCAC will host its Annual Conference and Institute of Government courses at the Wild Dunes Resort on the Isle of Palms, July 31-August 3, 2023. Please note the new conference schedule.

In order to maximize the room block for registered county officials, SCAC must receive a completed registration before the Wild Dunes Resort reservation link will be sent (within two business days). Institute of Government registrants will receive the reservation link via email within two business days. Anyone registering for the Annual Conference ONLY will receive the Wild Dunes Resort

for the Annual Conference ONLY will receive the Wild Dunes Resort reservation information the first week in April or within two business days if the registration is received April 3 and after.

## **Cancellation Policy**

# To cancel an Annual Conference and/or Institute of Government registration, you must notify the SCAC office in writing.

Registrations cancelled by 5 p.m. on July 21 will be assessed a \$10.00 service charge (Institute) and \$25.00 service charge (Annual Conference). After this date, no refunds will be made.

#### **Conference Attire**

For the comfort of our delegates, casual attire is acceptable at all business sessions. Attire will be dressy casual for the President's/ Corporate Partners' Reception and dressy for the Closing Reception. Dressing in layers is recommended due to room temperature variations.

#### **Institute of Government**

SCAC, in cooperation with the Joseph P. Riley Jr. Center for Livable Communities, College of Charleston, will hold the Institute of Government for County Officials (Level I, Level II, and Advanced classes) Monday, July 31 and Tuesday, August 1. Credit for Level II courses will be given to county officials who have graduated from Level I or are within nine hours of graduating from Level I.

Each course is three credit hours. Credits for courses are valid for four years. To receive a certificate for Level I, 27 hours of instruction, including 18 hours of required and nine hours of elective topics, must be completed. To receive a certificate for Level II, 18 hours of instruction in Level II topics must be completed. Participants who graduate from Level I or Level II will be recognized during the General Session on Wednesday, August 2.

## **SCAC's Annual Awards Competition**

This year's annual awards competition will be held in Columbia on May 24. All entrants and winners will be recognized during the General Session on Wednesday, August 2. The competition and award announcements will be streamed live.

# Wild Dunes Resort, Isle of Palms

A reservation link will be sent to **registered county officials only** within two BUSINESS DAYS of registering for either the Institute of Government or the Annual Conference. Institute of Government registrants will receive the link first. Those registering for the Annual Conference ONLY will receive the Wild Dunes Resort reservation link the first week in April or within two business days if registration is received April 3 and after. Please note that only individuals who are **REGISTERED** to attend will be able to book accommodations. One room per registrant.
