PalmettoPride Offers Litter Crew Grants to Local Governments

PalmettoPride announced the opening of its Litter Crew Grant process on September 23, and the deadline to apply is December 1. Visit: palmettopride.org/grants/litter-crew-grant/

Eligible Applicants

The grants are open to town, city or county governments. Funds may be used to start up a local cleanup program or to supplement an existing program. Trash bags will be provided by PalmettoPride. Applicants must provide a litter pickup plan including a full budget and use PalmettoPride's grant reporting website on Submittable.



Palmetto Pride reserves the right to reject all proposals and not award any grant funds under this solicitation. Failure to follow the directions outlined in

the application guidelines will result in the application not being considered for funding.

Purpose

Each Litter Crew Grant, awarded on a competitive basis, provides funding of up to \$25,000 to municipalities and counties to pay for litter removal crews. The governing organization should prioritize municipal or county maintained roads that would be unsafe for volunteers, roads that require routine maintenance, state highways, as needed, and hot spots.

PalmettoPride maintains that litter prevention is best, but pickup is an important part of litter prevention. Routine pickup helps reduce litter on roads and foster community pride.

Program mentors are available for establishment of new programs.

Additional Program Requirements

PalmettoPride requires that recipients use these funds to implement a litter prevention campaign in their counties if there is not one

already. PalmettoPride can assist in this part of the program upon request.

Grant Period

Each Litter Crew Grant will be for one year, with a targeted start date of Jan. 1, 2022. Special requests will be taken on an as-needed basis. PalmettoPride will dispense funds bi-annually dependent on activities and reports submitted and approved.

SCAC Offers Institute of Government Courses Online

The following are the courses currently available online as of November 2021:

ability and adoption of technology and the COVID-19 pandemic, SCAC has placed an emphasis on making Institute of Government for County Officials (Institute) courses available online. Historically the courses have only been offered in-person three times per year.

Now, however, the online versions of the courses are always accessible for county officials with a computer and internet connection. This includes from the comfort of home. Further, the online courses can be started, stopped, and resumed allowing participants to complete them at their own pace.

The online courses may contain interactive elements such as drag-and-drop questions, quizzes, videos, and recorded training by qualified instructors. Upon completion, participants will earn the



Level I

Orientation to County Government I [R] and Orientation to County Government II [R] are both offered online free of charge for county officials. These two courses are required to be taken in Level I of the Institute of Government as they cover foundational topics that all county officials should know. Furthermore, these courses are not offered individually in-person at SCAC conferences, so county officials are encouraged to take them online or attend SCAC's Newly-Elected Orientation for County Officials when it is hosted next in-person to earn credit for

both courses.

Strategic Planning [E] and Managing and Conducting Meetings [E] are also currently offered online. Strategic Planning focuses on the important of planning and goal setting within the policy-making process including the importance of a shared county vision and mission and linking the plan with the budget is stressed. Managing and Conducting Meetings is designed to help county officials learn how to conduct successful meetings. Additionally, this course is approved to provide planning and zoning continuing education credit in accordance with the state requirements set by the South Carolina Planning Education Advisory Committee (SCP-EAC). Both courses have an \$80 registration fee.

Level II

The following three Level II courses are currently offered online: Financial Management, The Policy Role of Council, and The Property Taxation Process.

Financial Management focuses on the basic elements of financial management and the role elected officials have in county financial decisions along with exploring various budgeting methods and other topics.

The Policy Role of Council is designed to help council members understand and carry out their responsibility as the elected policy-making body.

The Property Taxation Process examines the property taxation process in South Carolina with an emphasis on the most recent changes. All three courses have an \$80 registration fee.

Finally, SCAC currently offers one **Advanced** course online which is available for any county official to take but designed for participants who have already completed Level I and Level II coursework. The course is **Putting Dollars to Work for Your County: State & Local Coronavirus Fiscal Recovery Funds** and consists of a panel discussion on the American Rescue Plan Act's

(ARPA) Fiscal Recovery Fund and Treasury's guidance in addition to the Government Finance Officers Association's recommended principles for local governments to consider when deciding how to use the money. Information is also covered on the General Assembly budgetary plan and on the state's investment and grant opportunities for broadband. This course has an \$80 registration fee.

NEWS BRIEFS

Decennial Census—The South Carolina Revenue and Fiscal Affairs office (RFA) posted the Federal Decennial Census Data as adopted by the State on its website (**rfa.sc.gov**) on August 18, 2021. This data is necessary for each county to complete its redistricting process as required by the South Carolina Code of Laws.

Redistricting—All county council districts must be reapportioned as to population by the county council within a reasonable time prior to the next scheduled general election following the state's adoption of the Federal Decennial Census (SC Code Section 4-9-90). Counties will need to complete this process for the next general election on November 8, 2022. SCAC recommends that county officials consult with your county attorney to begin the redistricting process if you have not already done so. SCAC Scholarships—Applications are now open for SCAC's Presidential and Board of Directors Scholarships. This year's Presidential Scholarship will be awarded in the amount of \$2,500 to one graduating High School Senior from Oconee County. The Board of Director's Scholarships will be awarded in the amount of \$2,500 to one High School Senior from each of the following counties chosen by lot: Allendale, Horry, Newberry, and Williamsburg counties. Scholarship applications are due by February 1, 2022.


The SC Office of Resilience Seeks Public Input—Plans are underway by SCOR to develop a Strategic Statewide Resilience and Risk Reduction Plan which will identify major flood and potential losses that could occur from extreme weather events. TRSWA Dedicates Administration Building in Honor of David K. Summers Jr.

The Three Rivers Solid Waste Authority (TRSWA) Board of Directors dedicated its administration building in Jackson on July 15 in honor of Calhoun County Council Chairman David K. Summers Jr.

Summers chaired the TRSWA from its inception in December 1992 and the landfill's opening in July 1998 to his resignation from the agency's board due to health reasons in February 2021. Although he always wanted the TRSWA's administration building to be constructed at the landfill site, the building was not completed until 2013

"David is a true leader, a great leader and, without him, the TRSWA and its landfill would probably never have happened," said Eric Thompson, former General Manager



Summers represented Calhoun County as part of the TRSWA, governed by a representatives of nine counties: Aiken, Allendale,

Bamberg, Barnwell, Calhoun, Edgefield, McCormick, Orangeburg and Saluda. He was one of the agency's longest serving founding board members.

About 50 people attended the dedication ceremony, including TRSWA staff members; TRSWA and Solid Waste Technology Center board members; county administrators and council members; and Summers' family.

Eric Thompson, First General Manager of the TRSWA, described the many accomplishments made under Summers' leadership. Theresa H. Taylor, Allendale County Council Chairwoman, and Charles T. Jennings, McCormick County Council Chairman, presented Summers a plaque that is placed in his honor within the building's foyer.



Did You Know?

S.C. State Ethics Commission:

Did you know that public employees should not use government resources to assist candidates for office, including incumbents, with filing their campaign reports?

This means that public employees should not be working on campaign activity during business hours, while using government issued property such as computers or cellphones. This does not preclude a public employee



from working on a political campaign on their own time, using their own property. For more information please see 8-13-1346 of the Ethics Reform Act.
