# Weekly Update: Coronavirus Pandemic Whole-of-America Response

Tuesday, June 16

## **Medical Supplies and Equipment**

- As of June 12, FEMA, HHS, and the private sector combined have coordinated the delivery of, or are currently shipping: 152.2 million N95 respirators, 615.7 million surgical masks, 21.5 million face shields, 273.8 million surgical gowns/coveralls and over 15.5 billion gloves.
- As of June 14, FEMA has shipped 14,965 deliveries of medical supplies to nursing homes to 53 states and territories. <u>FEMA coordinated two shipments</u> totaling a 14-day supply of personal protective equipment to all 15,400 Medicaid and Medicare-certified nursing homes. The shipments are meant to supplement existing efforts to provide equipment to nursing homes.
- In support of the U.S. Department of Veterans Affairs and our nation's veterans, FEMA has coordinated shipments of more than 6.6 million respirator masks, 500,000 surgical masks, more than 3.3 million gloves, 424,000 face shields and 30,000 surgical gowns to facilities across the country.
- The federal government has approximately 23,606 total ventilators available in the Strategic National Stockpile.
- FEMA continues to expedite movement of commercially pre-sourced and commercially procured critical supplies from the global market to medical distributors in various locations across the U.S. through <a href="Project Airbridge">Project Airbridge</a>.
  - As of **June 15**, Project Air Bridge has completed 221 flights with an additional 27 scheduled or in transit, for a total of approximately 248 flights.
  - As of **June 15**, the following supplies have been delivered into private sector supply chains through Project Air Bridge: nearly 1.5 million N95 respirators; 937 million gloves, 112.8 million surgical masks, 44.4 million surgical gowns, more than 2.4 million thermometers, more than 2.5 million face shields, 1.4 million coveralls, 109,000 stethoscopes, 370,000 oxygen masks and more than 160,000 cannulas.
- Three non-Airbridge flight carrying FEMA-procured Hanes gowns arrived yesterday, June 15: one in Los Angeles, one in Chicago and one in Newark, New Jersey. Six flights are scheduled to land today in two in Los Angeles, two in Miami, one in Atlanta, and one in Newark, New Jersey. Since May 20, 79 non-Airbridge flights carrying over 11.8 million Hanes gowns have landed in the U.S.
- Since April 12, 51 non-airbridge flights carrying over 68.0 million FEMA-procured masks and respirators from 3M have landed in the U.S.
- To date, FEMA, HHS and the Cybersecurity Infrastructure and Security Agency (CISA) along with other federal agencies are processing and distributing over 346 million cloth face coverings for critical infrastructure workers.

#### **Testing**

- As of **June 15**, CDC, state, and local public health labs and other laboratories have tested more than 23.2 million samples.
  - As of **June 12**, the FDA has issued 135 individual <u>emergency use authorizations</u> for test kit manufacturers and laboratories, including 20 antibody tests and one antigen test.
- To support the Administration's <u>Testing Blueprint</u>, FEMA is working to source and procure testing material – specifically, testing swabs and transport media.
  - As of June 15, FEMA has procured and delivered 25.9 million swabs and 16.3 million units of media.
  - The FEMA-sourced material will be provided to states, territories and tribes for a limited duration to help increase testing capacity in support of their individualized plans.
- As of **June 15**, 262,187 samples were processed at federally run <u>Community-Based Testing Sites</u> and 607,686 samples were processed at public-private partnership testing sites.
  - Out of 41 original Community-Based Testing Sites, 13 continue to operate as federally run sites, 20 have transitioned to state management, and eight have closed in consultation with the states.
  - HHS has established a public-private partnership with pharmacy and retail companies to accelerate testing. To find locations, visit the <u>COVID-19 Community-Based Testing Site</u> <u>page</u>.
  - Under the CBTS public-private partnership, there are currently 573 live sites in 48 states
    Washington, D.C. and Puerto Rico conducting testing.

## **Federal Funding**

- Combined, FEMA and HHS have obligated \$108.8 billion in support of COVID-19 efforts.
- All 50 states, five territories, the Seminole Tribe of Florida, and Washington, D.C. have been approved for major disaster declarations to assist with additional needs identified.
  - To date, there are 84 tribes working with FEMA, with one tribe that is a direct recipient with a major disaster declaration and an emergency declaration, 43 tribes that are direct recipients with emergency declarations and 41 tribes that are recipients under state declarations.
  - A tribal government may choose to be a subrecipient under a state that has chosen to be a recipient of FEMA assistance, or choose to be a direct recipient of FEMA.
- As of June 14, FEMA has obligated \$7.1 billion in support of COVID-19 efforts. This support includes:
  - Emergency Food and Shelter: \$200 million.
  - Temporary Medical Facilities including medical personnel, mortuary and ambulance services: \$2.4 billion.
  - PPE including medical supplies and pharmaceuticals: \$1.9 billion.
  - National Guard: \$1.6 billion.
  - Public Assistance Emergency Protective Measures (Non-PPE): \$866 million.
  - Commodities: \$27 million.
  - Crisis Counseling: \$29 million.

### **Additional Federal Support**

- FEMA has 2,552 employees supporting COVID-19 pandemic response out of a total 20,605 agency employees ready to respond to other emergencies should they occur.
- To date, the President has approved 50 National Guard requests for federal support for the use of National Guard personnel in a Title 32 duty status through August 21.
  - As of June 15, 32,389 National Guard troops have activated in T-32 duty status and 676 troops have activated in State Active Duty status to help with testing and other response efforts.
  - Troops have been supporting the response through meal service or deliveries, conducting COVID-19 testing, disinfecting long-term care and correctional facilities, providing staff to community and government agencies and constructing alternate care facilities and other sheltering facilities.
- As of June 11, the CDC has 5,505 personnel supporting the outbreak response.
- As of June 10, U.S. Public Health Service Commissioned Corps has deployed more than 4,300 officers in support of the nation-wide efforts to mitigate the spread of COVID-19.
- As of June 10, 81 USACE personnel are activated to support the COVID-19 mission, with more than 251 personnel engaged in additional response efforts.
- As of June 16, 93 agencies across 29 states, the District of Columbia, two tribes and one U.S. territory have sent a total of 302 alerts containing information on COVID-19 to cell phones and other wireless devices via the WEA system, and 67 alerts to radios/televisions via EAS.
