### **FINAL REGULATIONS**

#### **Governor's Office: State Emergency Management Standards (Doc. No. 4703)**

The Governor's office updated the language of R.58-101. State Emergency Management Standards, to include the role of the Adjutant General in emergency management as well as more precisely define the chain of command, coordination, direction, and control during an emergency. The revisions will help delineate the roles and responsibilities in emergency management at the state level.

**Board of Education: School Resource Officers (Doc. 4659)**

The State Board of Education created R.43-210, to establish a definition of “school resource officers,” along with expectations, roles, and procedures associated with these individuals.

**Building Code’s Council: Building Codes (Doc. No. 4714 – 4719)**

The South Carolina Building Codes Council amended the following regulations to correct scrivener’s errors:

- 8-604. Adoption of Model Codes.
- 8-255. Energy Standards Appeal Procedure.
- 8-1218. IRC Section R502.11.4 Truss design
- 8-1221. IRC Section R703.4 Flashing
- 8-1222. IRC Section R802.10.1 Wood Truss Design.
- 8-120. Maximum Time for Certification.

**Transportation Project Prioritization (Doc. No. 4683)**

South Carolina Department of Transportation (SCDOT) amended Regulation 63-10 regarding Transportation Project Prioritization to add new definitions; change the name of the “State Comprehensive Plan” to the “Statewide Multimodal Transportation Long Range Plan” (“Multimodal Plan”); clarify that there are multiple project ranking lists in each program category, not one statewide ranking list; delete State Infrastructure Bank projects as projects not subject to the project prioritization process; clarify how SCDOT considers the 57- 1-370(B)(8) criteria in its project development process.
